## Introduction

## **About the Programme**

The Joint Operational Programme "Black Sea Basin 2007 - 2013" is one of the EU's operational programmes under the European Neighbourhood & Partnership Instrument (ENPI). There are 8 participating countries in the Programme: Armenia, Bulgaria, Georgia, Greece, Moldova, Romania, Turkey and Ukraine. The Black Sea Basin Programme aims at a stronger and more sustainable economic and social development of the Black Sea Basin regions. Through this Programme, communities in the concerned areas are encouraged to further develop their local economy, confront environmental challenges and promote greater interaction among people.

The Programme is financed by the ENPI and the participation of Turkey is financed by the Instrument for Pre-accession Assistance (IPA).

The Black Sea Basin JOP is characterised by a number of specificities regarding eligible area, the priorities and measures, and the potential applicants. The full details of the programme can be found in the Programme documents, available on our website. The official language of the Programme is English.

\*The indicative allocation of IPA funds to finance the participation of Turkey in the Programme is 1,000,000 Euro per year confirmed on a yearly basis through annual financing decisions.



## **Second Call for Proposals**

Three years have passed since the Programme was approved by the European Commission. Since then, the Programme has kept growing in terms of budget allocated, bodies involved and operations carried out.

2011 has been a year with important changes in the progress of the Programme. In this section you will find information about main developments, operations and achievements during 2011 as well as roles of the involved bodies.

The section "Projects Under Implementation" provides an overview of the projects under implementation within the Programme.

## Second Call for Proposals

The Joint Managing Authority (JMA) launched the Second Call for Proposals on the 30th of June 2011. All priorities of the programme were open for submission of proposals.

The indicative amount made available under the Second Call for Proposals is 15,169,098.86 euro (ENPI contribution). For Turkish partners' participation in joint actions, the indicative amount made available under this call for proposals is 5,300,241.30 euro (IPA contribution). No grant will exceed 90% of the total eligible costs of the Action. The rate of co-financing is 10% of the total eligible costs of the Action and it is requested for each approved proposal. Co-financing has to be provided by the beneficiaries in order to demonstrate local commitment.

In order to increase the quantity and quality of the project proposals, in 2011 the Programme bodies carried out series of events.



Within the context of the Second Call for Proposals, the JMA together with the Regional Capacity Building Initiative (RCBI), the National Authorities from the countries participating in the Programme and the National Info Points (NIPs), organised partnership forums, project preparation workshops and info days supporting the potential beneficiaries in developing quality projects that contribute to reaching the indicators set up in the joint operational programme.







## **Second Call for Proposals**

#### Helpdesk

A helpdesk was established at Programme level within the Joint Technical Secretariat (JTS) and within the National Info Points. The helpdesk provided information to potential applicants and partners on various specific issues of the Second Call for Proposals, with the assistance of the JMA. The JTS at programme level was in close connection with the NIPs in the Programme countries throughout the call process.

An e-mail address named Infocall was created specifically for providing information to the potential applicants and partners at Programme level. In total, 234 questions included in 180 e-mails were answered in writing via Infocall.







## **Applications and Evaluation Process**

194 applications have been submitted under the Second Call for Proposals. Following the approval by the JMC of the Evaluation Report, Step 1 - Opening & Administrative Checks, the chairperson of the Selection Committee will send letters to all applicants, indicating whether their application was submitted prior to the deadline, informing them of the reference number they have been allocated and whether their application has been recommended for further evaluation. The Opening & Administrative Check represents the first step in the evaluation and selection process of projects submitted under the Second Call for Proposals.

Following this step, evaluation of Grant Application Form will take place which represents the second step. The third and last step is eligibility check. After each step, the applicants will be informed about the results of the evaluation.

## First Call for Proposals

### First Call for Proposals: Contracting and Implementation Process

The contracting process of the projects awarded under the First Call for Proposals started in December 2010. Currently, 13 contracts are signed and their implementation has started.

As projects started to go under implementation, the first training on grant implementation for beneficiaries and partners of the projects under the First Call for Proposals was organised in Bucharest on the 1st and 2nd September 2011. The training, which was organised by JTS and JMA with the support of RCBI, was an opportunity for the beneficiaries and partners of the projects to become aware of the specific implementation rules such as procurement rules, project management, reporting, visibility requirements etc. During the training, participants were also provided the chance to realise consultations with their project managers and meet and discuss with their project partners/beneficiaries in personal meetings.

The second training on grant implementation was organised on the 24th and 25th November 2011, in the same format, additionally with involvement of the National Info Points representing the Programme countries, in order to continue the cooperation with NIPs in the project implementation process. The cooperation with NIPs have already brought about fruitful outcomes in supporting the potential beneficiaries and partners.









## The Joint Technical Secretariat



JTS was established in June 2011 and is located in Bucharest, Romania.

JTS is the administrative and secretarial body of the Programme, responsible for day-to-day management and acting as contact point for potential applicants as well as grant beneficiaries.

JTS performs its activities under the supervision of JMA, the Ministry of Regional Development and Tourism, Romania.

The expenses for functioning of the JTS are financed through a direct grant approved by the European Commission.

Currently, four positions are occupied in the organisational structure of the JTS, by the Head of JTS, two project managers and an information and communication manager.

## Involvement of the Programme Management Bodies

The JMA and the JTS, the two offices at the centre of the Programme have provided day to day management of the Programme. They have been in close connection with the other bodies involved in the management of the Programme.

Regional Capacity Building Initiative provided intensive support to the two main management bodies in reaching potential applicants and partners, providing necessary reliable information to them, regarding application procedures, project preparations, call's necessities etc. This support continued in the implementation process with the participation of RCBI experts in training seminars organised by the JTS and JMA, providing information to the beneficiaries of the projects and their partners, about the specific implementation rules such as procurement rules, project management, reporting, visibility requirements etc.

The Interact ENPI supported the JMA and JTS staff in the management of the Programme, by providing specific information and organising events which served as platforms where similar Programme stakeholders could discuss and share their experiences.

The National Authorities have been in close connection with the JMA and have provided support in organising the events, also providing necessary contribution prior to and after launching the Second Call for Proposals.

National Info Points of the Programme in each country have also been in close connection with JMA and JTS, have provided intensive and effective support in organizing events, offering the necessary input to the publications, as well as providing information to the potential applicants and partners and helping them in their partner search.
