





ADDENDUM N°1 TO GRANT CONTRACT N° 2.1.2.74072.334 MIS-ETC 2675

have agreed as follows:

The following provisions of Contract < Black Sea Silk Road Corridor (BSSRC) 2.1.2.74072.334 MIS-ETC 2675 concluded between the Contracting Authority and the Beneficiary on < 07.01.2013 > (the "Contract") are hereby replaced/completed as follows:

1. Modification of the budget lines

Modification of the budget lines related to the subcontracted services for manufacturing, transportation and installation of directional signs, informational panels, plaques and markers (budget lines: 5.9.11 Subcontracted Services for Manufacturing/Assembling 18 direction signs and 15 trail markers /GA1/1.1, 5.9.12 Subcontracted Services for Transportation of 18 direction signs and 15 trail markers/GA1/1.1, 5.9.13 Subcontracted Services for installation works of 18 direction signs and 15 trail markers /GA1/1.1, 5.9.14 Subcontracted Services for Manufacturing 40 panels and 30 plaques /GA1/1.2, 5.9.15 Subcontracted Services for Transportation 40 panels and 30 plaques /GA1/1.2, 5.9.16 Subcontracted Services for installation works of 40 panels and 30 plaques /GA1/1.2) and Electronic maps (budget line 6).

More specifically, change of the description of the above mentioned budget lines by changing the unit description from "PER MONTH" to "PER SERVICE", taking out trail signs and markers by increasing the number of panels from 40 to 60 and decreasing the number of directional signs from 18 to 12 of the subcontracted services for manufacturing, transportation and installation of directional signs accordingly changing the totals of each budget lines and transfer of the total amount of the budget line 6 to the budget lines for manufacturing, transportation and installation of the informational panel budget lines.

Justification:

In the approved project budget "Tadzreli" Foundation planned to prepare and install:

- 1. 40 informational panels and 30 plaques.
- 2. 18 directional signs and 15 trail markers

Georgian law prohibits affixing plaques and informational panels on a monument, consequently the 30 plaques could not be installed. In order to provide the same level of touristic information that was approved in the original project, the decision was made to increase the number of information panels from 40 to 60. It also became apparent during the detailed survey of the route that there are more than 40 historic-cultural monuments and landscapes on the trail. Therefore, to improve the touristic value of the trail, the installation of additional information panels – in place of plaques - will significantly improve a tourist's impression of Georgia by including more monuments on the route at no additional project cost.

With respect to directional signs and trail markers, after meetings with the appropriate Georgian government agencies, the appropriateness of installment of 18 directional signs and 15 trail markers was revised. Under Georgian law, the standard for placement of traffic symbols along Georgia's roads, prohibits installation of the originally planned traffic signs. All traffic signs must conform to current national standards, and many of the monuments and landscapes along the trail were already marked by government installed signage. The Government agencies refused to permit duplication of existing government signage. After route survey and consultation with government agencies, only 12 areas did not currently have government signage, so the decision was made to install only 12 standard directional signs on key highways and major routes.

These changes are reflected in the project budget. These changes make no overall change to the cost of the project, but will comply with Georgian law and will improve the professional appearance and utility of the Georgian portion of the Black Sea Silk Road Corridor trail.

For all countries finalization of sites and monuments; site selection, research and content creation commenced; authority permissions secured; translation of content for panels and plaques into 5









languages commenced; design and manufacturing of signs, panels, plaques and markers begun; installation arrangements secured. Baseline survey of sites.

Armenia: 114 panels, 148 directional signs, 77 markers and 55 plagues for 43 sites on the Armenian portion of the BSSRC (installed in Armenia).

Georgia: 60 panels, 12 directional signs, for 60 sites on the Georgian portion of the BSSRC (installed in Georgia).

Greece: 28 panels, 50 directional signs, 15 markers and 18 plaques for 15 sites on the Greek portion of the BSSRC (installed in Greece).

Turkey: 200 panels, 300 directional signs, 1000 markers and 30 plaques for 100 sites on the Turkish portion of the BSSRC (installed in Turkey).
