Overall Objective:

The project is aiming to achieve a *stronger regional partnership and cooperation to realize significant improvements of the wastewater treatment facilities management in the Black Sea coastal states.*

Specific Objectives:

1. Cooperation between Black Sea partner regions, in order to improve the management of the wastewater treatment facilities.
2. To increase the performance of wastewater treatment facilities through a new, continuous improvement strategy - CIS model development.



Main Activities:

- Documentation elaboration to define and implement the continuous improvement strategy (CIS) in wastewater treatment facilities (WWTF).
- Balanced Scorecard elaborating to measure, monitor and communicate the WWTF performance.
- CIS training of regional operators, agencies, universities and institutes personnel involved in environmental protection and wastewater management.

Expected results:

- Expert knowledge on the situation of wastewater management and sustainable development increased in the Black Sea region.
- New concept developed to improve the management of wastewaters treatment facilities in 6 countries, with direct access to the Black Sea or clearly integrated to the BS Basin.
- Increasing WWTF performance, by implementing the CIS concept in Romania, Region of South-East and in Greece, Anatoliki Makedonia -Thraki Region.


