### Overall Objective:

The project is aiming to contribute to the sustainable economical and social development in the Black Sea region, by valuating its natural, historical and cultural richness and strengthening the management capacity of the outdoor tourism.

## Specific Objectives:

- 1. To identify the opportunities and the obstacles in the tourism sector, in order to achieve sustainable economic development in the region.
- 2. To develop a sustainable outdoor adventure tourism strategy and an action plan for the region.
- 3. To increase the management capacity of local institutions, tourism operators and small enterprises working in the field.
- 4. To promote the outdoor adventure tourism as a tool for obtaining sustainable economic development, stimulating business cooperation.

#### Main Activities:

- Assessment of actual outdoor tourism activities in the Area.
- O Establishing the Outdoor Adventure Tourism Network.
- O Setting up an Outdoor Adventure Sports Tournament in the region with the participation of each partner countries.
- O Elaboration of a Strategy for Outdoor Adventure Tourism Activities' Development and Promotion.

### Expected results:

- A Regional Assessment Study, including Quality Assessment of existing outdoor tourism activities, issued in English.
- A public consultation conducted in each partner country, with an assessment questionnaire.
- A Network Agreement in English signed by the partners.
- An Outdoor Adventure Sports Tournament settled up in the region.
- The Strategy for Outdoor Adventure Tourism Activities' Development and Promotion elaborated in English.
