**Overall Objective:**

The project is aiming to increase the administrative capacity of the public sector in the programme area, by promoting the concept of total quality and the implementation of modern common quality management tools.

**Specific Objectives:**

1. To adopt the Common Assessment Framework (CAF) model as the common tool for public entities diagnosis and improvement.
2. To create a critical mass of organisations that improved their capacity by implementing the CAF model and act as role models in their areas.
3. To create a high level trained trans-national group of experts that will facilitate the public organisations to implement the CAF during the project and in the future.
4. To exchange knowledge, experiences and best practices among partners involved.
5. To achieve a strong interregional partnership and cooperation by creating a network that will expand the scope of the project.

**Main Activities:**

- Implementing trainers training and pilot applications.
- Enrolling pilot implementations of the CAF model.
- Implementing exchange of experience (study visits).
- Developing a good practices database.
- Issuing a good practices guide.

**Expected results:**

- 1 cross border partnership for local development created
- 6 entrepreneurs / economic agents involved in project activities.
- 7 local administrations involved in initiatives for capacity building.
- 1 researched / established link of information, communication, transport and trade.
- 1 project partnership establishing permanent economic relations between the economic actors from different countries after the end of project's activities.
- 7 local administrations and organizations that activate new types of services or new ways of providing existing services.

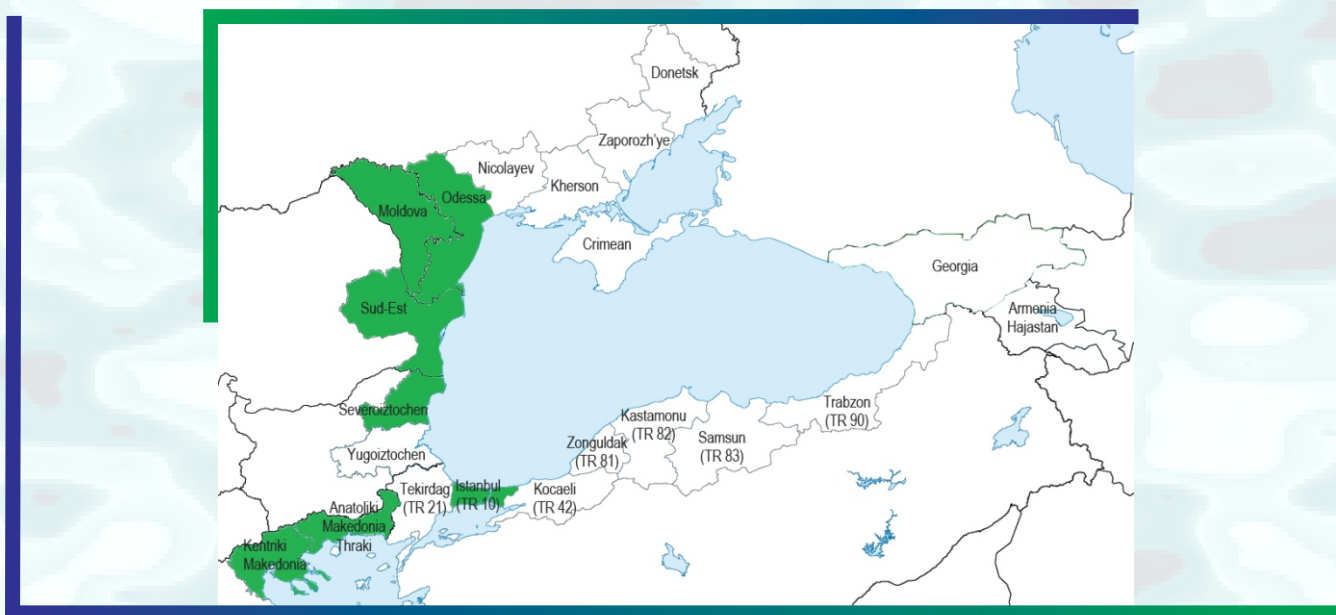
