Overall Objective:

The project is aiming to create a network of research, cultural and administrative institutions for a long term promotion of the scientific and cultural values exchange within the Black Sea Basin, so that the entire cultural heritage from the Roman epoch to be integrated, preserved and joint promoted.

Specific Objectives:

- 1. To achieve a permanent exchange of experience between scientific, cultural, administrative institutions for the purpose of knowing, protecting and promoting the archeological heritage by joint actions.
- 2. To put up a transnational body: the Association "Center for Roman Archeological Heritage Studies in the Black Sea" active in the long term.
- 3. To point out the cultural diversity of the Black Sea Basin regions during the Roman epoch as a model of integration vs. globalization.
- 4. To create thematic itineraries of Roman archeology in the Black Sea Basin.
- 5. To generate, within the young generation, of a pro patrimony attitude
- 6. To develop a model of good practices in the protection and promotion of the cultural heritage dated to the Roman epoch of the circumpontic area.

Main Activities:

- Implementation of cultural events and dissemination of promotional materials.
- Organization of joint exhibition.
- Organization of thematic workshop.
- Organization of the -Archeology School".

Expected results:

- A network of scientific institutions (research institutes), cultural institutions (museums), educational institutions (universities), institutions of the local administration and of the civil society which shall get involved in the activity of research, protection and valorization of the archeological heritage of the Roman epoch.
- A fully functional center for the study of the Roman heritage in Black Sea Basin, on associative principle.
- A database with all Roman sites of the areas where the project partners are active.
- A joint multilingual exhibition catalogue and CD for the promotion of the Roman archeological heritage.
