

## Current per diem rates

In the framework of EC-funded external aid contracts and in case of missions requiring an overnight stay away from the base of operations, the applicable rates to the per diems must not exceed the scales detailed hereunder. These rates are applicable from 10 July 2011

Per diems cover accommodation, meals, local travel within the place of mission and sundry expenses
