# **EXPECTED RESULTS**

- 2 Calibrated hydrologic models implemented in 5 pilot areas;
- 2 Indices based satellite and drone images: Normalized Difference Vegetation Index (NDVI) and Normalized Difference Water Index (NDWI), to map the most vulnerable areas on soil erosion and consequently on source of pollutants by using free satellite images;
- 5 Fingerprinting Methods based on the soil sample collected from soil surface, stream banks, stream beds and stream water samples;
- A **Multi-Criteria Decision Analysis** to identify the most vulnerable locations on erosion and littering;
- 5 Innovative tools to mitigate litter stream pollution develop and installed in the pilot areas to mitigate litter and pollution.
